## General explanation

Wanawake Tunaweza Tanzania is an international NGO, born of a Tanzanian-Dutch cooperation, seeking to advance women's prospects by focusing on their economic and social enablement, and by supporting the creation of joint, sustainable small enterprises.

## Activities

Arranging and running online and face-to-face coaching sessions for women's groups located in and around Arusha, Northern Tanzania. For that purpose, the foundation works with a project coordinator at location.

#### Notes to the balance sheet and income statement

Foundation Wanawake Tunaweza Tanzania was officially launched on 16 April 2024. Before that date, it was a private initiative, for which the donations were already available through a private bank account.

The activities were already carried out according to the vision and objective of the Foundation Wanawake Tunaweza Tanzania as it was established on 16 April 2024. Therefore, the balance sheet and income statement for 2023 already provided a fair reflection of the financial situation of the foundation the moment the foundation was officially launched.

After 16 April 2024, the foundation acquired its own bank account. The remaining funds from the private initiative were transferred to the foundation.

#### Notes to the balance sheet

#### Assets

- 1. The only assets of the foundation consist of current assets, being funds in the foundation's bank account.
- 2. The funds in the bank account are valued at nominal value.
- 3. The funds are fully available for the objective of the foundation.

#### **Own equity**

1. Funds available for projects must be fully spent on the foundation's objective.



#### Notes to the income statement

- 1. The balance is determined as the difference between total income and total expenditure over the financial year.
- 2. The expenditure for the foundation's objective consists of costs for running the remote and face-to-face meetings with the women's groups in and around Arusha.
- 3. This expenditure consists of:
  - an allowance for the project manager;
  - costs for the internet connection between Tanzania and the coach that is teaching remotely, currently mainly from Europe;
  - transport costs for the project manager to go to the meeting locations;
  - costs for stationary;
  - costs for special events organized according to the objective of Wanawake Tunaweza Tanzania at the benefit of all the women's groups.
- The requested legal advice in 2023 concerned the registration of the foundation in Tanzania. The registration itself will also (partly) be funded from this amount. The final payment was made at the date of completion of the registration in Tanzania, 10 December 2024.

#### Events after balance sheet date

There are no relevant after balance sheet dates events.
